#### **Student Teacher Supervision:**

From 2006 to 2011, I supervised the Art Student Teacher Program (NYS Visual Arts K-12) at The College of New Rochelle. Placements have included New Rochelle, Harrison, White Plains, Buchanan, Brewster, Bronx, Manhattan, etc. In the Fall of 2011, this expanded to include a class Seminar, The Art of Teaching Art. Many of the full-time

art teachers in the various schools visited are my previous CNR students. It has been extremely rewarding to be involved in so many art teacher careers.

#### **Activity Summary:**

Over the years, I have been invited as artist-in-residence and lecturer in public and private schools locally and nationally, have lectured on my work, on the history of the art gallery to include cooperative, artist-run and other alternative galleries, art materials' hazards, on concepts particular to the studio teacher, and arts management/art marketing for the New York State Council of the Arts, Westchester Council on the Arts, Westchester Art Workshop, local colleges and universities, and regional art and educational organizations. With the second edition of my book, I have been invited by numerous organizations to lecture on its contents, as well as serve as reviewer for several texts on printmaking and the fine arts for Prentice-Hall, Watson-Guptil and Macmillan. I have served on many panels that have dealt with such subjects as health hazards in the arts, the business of art, and artist's rights, as well as David Rockefeller's arts education study panel Coming to Our Senses. I served as curator to the Federico Castellon Memorial Print Collection at Russell Library, Columbia University, Macy Gallery Student Director at Teachers College, Co-Director of the Ziegfeld Gallery at Teachers College, Columbia University, the College of New Rochelle's Curatorial Committee, the Board of Directors for the Castle Gallery, the Advisory Board of the Hudson Valley Center for Contemporary Art, the Board of Governors for the Robert Blackburn Printmaking Workshop of the Elizabeth Foundation, The Upper View Gallery of the Paramount Center for the Arts, The Hat Factory Clay Art Center, etc., and continuously assist in curatorial and gallery duties for various institutional shows. I was actively involved in postdoctoral work at Columbia University and other institutions in the areas of critical theory, aesthetics, arts education and art history. I conducted several graduate workshops and seminars in these and other art areas to include printmaking and painting workshops. I have designed core undergraduate liberal arts courses in art and visual thinking, as well as designing and implementing a revised postsecondary curriculum in art that includes a four year colloquium/seminar program, the inclusion of graphic design/computer graphics specialty, pre-professional programs in art therapy and art education, and a combined art/communication arts curriculum. I am presently working on a feasibility study for a proposed MA in Studio Art. While teaching in the Graduate Art Program of The College of New Rochelle, I rewrote several of the graduate art programs and implemented the Master of Science Studio Art degree. During my 1985/86 sabbatical leave, I served on the Exhibitions Committee of PADD organizing and curating two shows, "State of Mind/State of the Union," and "Concrete Crisis," which included original and poster prints for Exit Art Gallery under grants from the New York State Council for the Arts. The complete portfolio now is in several public collections to include MOMA and the Whitney Museum. Also during this leave I produced a new body of drawings and paintings on paper exhibited at LedisFlam Gallery in Brooklyn, Club 1080, the Palladium, etc., and CNR's College Center. During the Fall of 1989, I worked with the editorial staff of Social Policy (published quarterly by The Union for Experimenting Colleges and Universities) on "Grassroots Strategies for the Housing Crisis" which included images and essays from the "Concrete Crisis" portfolio and

support literature. I assisted in getting this portfolio included in exhibitions by the Public Art Fund, Inc. and the Goddard-Riverside Center during 1989, and the Peekskill Business Improvement District in 1997. During the last half of 1987, I reorganized a freelance partnership in printmaking into a production shop (Maxwell-Nova Fine Arts, Inc.) producing limited silkscreen editions for Martin Lawrence Limited Editions, John Szoke Fine Arts, individual artists such as Jerry Kerns, Dennis Adams, Robert Longo, Red Grooms, Julian Schnabel, Jacob Lawrence, Alice Neel and others. I was a member of the College's Task Force in 1987-88 that established a new technological center for the College of New Rochelle that included computer graphics, electronic publishing, electronic media, digital photography, printmaking on all levels, and new art history facilities, as well as two new professional college art galleries. In both 1987 and 1989, I was invited by the National Collegiate Honors Council to participate in a United Nations Semester "From Urban to Global Community" for which I conducted New York City seminars on the inter-relationships of art and politics. This included a celebration of the "French Revolution: Echoes and After Shocks," for which I served on a panel, "Art and Artistry in a Technological Age," presenting a paper "Electronic Media in a Postmodern Culture: It's art, but is it technology?" The content of this paper was included in another panel, "Facing the Arts and the Future" at Teachers College, Columbia University on February 3, 1990 in conjunction with their Distinguished Alumni Exhibition at the Macy Gallery. After serving two consecutive terms (six years) as Chairman of the Art Department (a rotating position) in the School of Arts and Sciences, College of New Rochelle, I chose to return to teaching and to the development of six new courses: Monoprinting, Innovative Printmaking, Collage/Assemblage, As the Artist Sees, Visual Thinking, and an Honors course "The Anatomy of a Metropolis: the Artist and the City." All six of these new courses have been offered and remain in the College Bulletin since their adoption by the Council of Arts and Sciences. Presently, I maintain the responsibility of the Art Department's Transfer Student program which includes the development of two-year college articulation agreements, consistent communication with Junior Colleges, and the recruitment and advisement of incoming transfer students. I am also the college's admissions liaison for all transfer students. I had a sabbatical leave in Spring 1995 during which time I completed a portfolio of prints combining both intaglio and monoprint methods that complemented a earlier series of paintings and drawings entitled "The Perfect Circle." I also traveled to Europe (staying at the house/studio of artist Sol Lewitt in Spoleto, Italy), touring Italy, Germany, Austria and Switzerland. During the 1996-97 academic year, I served as a Visiting Professor of Printmaking at SUNY Westchester Community College; the work of my WCC students was displayed in their annual student show, and I was invited to display my own work in a one-person exhibition in November 1997 in their main gallery. In November 1996, I opened a new studio in the Artist District of Peekskill, New York, retaining my NYC studio. I have been on the Board of the Peekskill Arts Council, was appointed to the Board of the Peekskill Educational Foundation in 2001, and appointed to the Advisory Board of the Hudson Valley Center for Contemporary Art (HVCCA) in 2005. I was extensively involved in the planning and implementation of several art Projects for the City of Peekskill and the HVCCA including the Peekskill Project from 2003-2006. In 2002, I started my own gallery and sculpture garden, williamMAXWELL FINE ARTS, Inc. that I directed. I originated, curated, organized and installed over 24 exhibitions in MFA

since its inauguration. It closed in 2011. In 2005, I established MFA@121, a satellite gallery at 121 Restaurant in North Salem, New York. I had six one-person exhibitions in Peekskill, New York City and The College of New Rochelle following my sabbatical leave in 1995. After my sabbatical leave in 2008, I had a one-person show at The College of New Rochelle's Mooney Center gallery. During the summer of 2006, I visited Prague, touring and researching their extensive art community including the very active printmaking community. I was selected to be on the Board of Governors of the Robert Blackburn Printmaking Workshop, now a program of the Elizabeth Foundation, which is dedicated to keeping this community printmaking workshop active and involved in the memory of Bob Blackburn. In 2008, I had two one-person exhibitions installed, "The Perfect Circle" at The Studio @ Madison Industries in NYC and "Selected Paperworks" at MFA@121. I continue working as the Art Department's Transfer Student Liaison, attending several portfolio workshops and recruiting new transfer students for the College. I supervised Student Art Teachers from the Fall 2005 to the Spring of 2010, that included a Seminar entitled "The Art of Teaching Art." For the last several years, I have been designing a new course, Digital Printmaking, which I expect will be offered in the near future. I taught for the academic year 2006-2007 a 4-credit Advanced Painting Seminar at WCC's White Plains campus, the Westchester Art Workshop (now The Center for the Arts), and taught two 2-credit Contemporary Painting Courses for several years at the Cenrter. During Spring 2008, I presented a Special Weekend Media Workshop in November at the Workshop. The summer of 2007, The Whitney Museum of American Art notified me that they included one of my art works in their permanent collection as part of the adoption of a portfolio of prints produced for PADD's "Concrete Crisis" project. This portfolio is also part of MOMA's permanent collection, and several other museums and libraries (including NYC Library) have, or are in the process of, including this portfolio in their collections. In 2008, I was included in a portfolio of 20 artists, The Peaceable Kingdom for The Robert Blackburn Print Shop, Elizabeth Foundation, which is now part of the New York City Library's and Congressional Library's collection, as well as The Brooklyn Museum collection, and other venues. In Spring 2008, I completed another sabbatical leave from The College of New Rochelle. During this time, I was selected to be one of seven curators for a special exhibition at Peekskill's Hat Factory, entitled For the Love of Art, which presented over 35 artists from the Hudson Valley. The exhibition was featured in the New York Times. Also, I participated in three Peekskill Arts Council exhibitions in Peekskill's Standard House. Also, I attended 4 workshops on digital printmaking. I organized a Peekskill Project citywide exhibition entitled Water Project 2009, that included 5 exhibitions, Tributaries: Collaborative Concepts @ MFA, Critters (signage project), WET! And Immersion (two video projects), and UNDERTOW: Thinking Water (a six person photography exhibition at The Paramount Center for the Arts). In the latter show, I exhibited my digital photographs for the first time. Water Project 2009 was part of Peekskill's citywide Quadricentennial Celebration of the Hudson River. UNDERTOW also included a panel, which I organized and moderated, in the theater of the Paramount Center for the Arts. I had a solo exhibition in March 2010 in the Mooney Center Exhibition Hall of The College of New Rochelle, where I exhibited my digital prints, along with an extensive series of monoprints completed at theRobert Blackburn Printshop of the Elizabeth Foundation during my sabbatical. At the same time, The Hat Factory under the direction

# of Ben Green, formed a committee, which I served on, to establish a Peekskill community art center to include a ceramics workshop at The Hat Factory. In June 2010, the Center for Ceramics at The Hat Factory became a reality. The March 2010 solo exhibition in the college's Mooney Center gallery, *recurrent PERFECT CIRCLE*, was a great success. This was the show's statement:

"This exhibition is displaying a selection of work begun and completed during my Sabbatical Leave in the Spring semester 2009. There are five areas of artwork that I explored during this period, extending it into the Summer and Fall of 2009 and Winter of 2010. They are encaustic painting, drawing, monoprinting, photography and digital printmaking. The encaustic painting is still in process and not ready to be exhibited, although the results are very promising. The two drawings shown are the beginning of a series entitled Perfect Circle: Diagnosis, and are meant as homage's to particular people that have passed away in a violent way and whose past presence and continued outstanding influence on this planet I feel are important to my becoming. The monoprints are from a series entitled Perfect Circle: Timeless Encounters and were all freely and enthusiastically printed at the Robert Blackburn Printshop, now part of the Elizabeth Foundation in New York City, with the assistance and encouragement of a printmaking colleague and dear friend, Bruce Waldman. They are controlled by adding "hand coloring" after the printing process and, as exists in all this work, they reference the clock as man's measure of time, juxtaposed onto the chaos of art and nature. Additionally, these perfect circle monoprints reference another "perfect circle," the meditative Mandala. The digital photography is a series called Perfect Circle: Picturing Time; nine of these photos were previously exhibited at The Paramount Center for the Arts in Peekskill, in a show called UNDERTOW: Thinking Water as part of a citywide project entitled Water Project 2009, which I curated and organized as part of Peekskill's celebration of Henry Hudson's exploration 400 years ago of the river now named after him. The digital prints exhibited in this show are a series entitled Perfect Circle: The Nature of Things, the photographic image of which were completed using Adobe Photoshop and an onSoft plugin. The sabbatical leave provided time to personally explore the potentials of digital printmaking as a fifth printmaking process recently added to traditional intaglio, planographic, serigraphic and relief printing. The original images were photographed in St. Barths and St. Martin, the Penobscot and Downeast coast of Maine, Norfolk and Virginia Beach, and the Outer Banks of North Carolina to include Ocracoke Island '

In July 2010, I inaugurated a new gallery in Stowe, Vermont, Directed by a CNR alum, Mia Feroleto, with some of my recent work, and in September, this new work from recurrent PERFECT CIRCLE was part of a two-person exhibition at The Center for the Arts, SUNY Westchester, in White Plains, New York. For the summer of 2010, The College of New Rochelle awarded me with a NEH Faculty Development Grant to further investigate the relationships between traditional printmaking and digital processes with the intention of designing and developing a Digital Printmaking course for the College. I attended 4 workshops on digital printmaking during this sabbatical and developed further my expanding portfolio of digital prints. I was chosen to be the Juror for the 10th Anniversary Exhibition of The Society of Etchers at the National Arts Club of New York City, which happened in November of 2010. On June 5, 2010, my gallery and sculpture garden in Peekskill, MAXWELL FINE ARTS, opened its 10th year with a solo exhibition of the sculptural work of Jo-Ann Brody, and a "Works in Progress" show of my work started during my 2009 Sabbatical Leave from the College. The exhibition continued through October 17, 2010. Following this exhibition, Maxwell Finer Arts closed in October 2011. Presently, I am Co-Director of Studio A Gallery in Tarrytown, New York with my partner, Athena Bing He, where several of Maxwell Fine Arts' artists exhibit, as well as many new artists recruited from New York ity to Kyoto, Japan. After 3 years of living and working in Cold Spring, NY after leaving Peekskill in 2010/2011, my studio and home is now located in Dobbs Ferry, New York. In the meantime, MFA exists as a virtual gallery. I also created a new website (www.williamcmaxwell.com) and Facebook page (www.facebook.com/pages/William-C-Maxwell-The-Perfect-Circle) in 2011 for my work entitled: William C. Maxwell "The Perfect Circle." I have curated several exhibitions with Athena since coming to Studio A Gallery, and I teach mixed media workshops in the gallery and host professional tours to art districts in New York.
